

Approval has been given for the issue of a badge to the wife and mother or nearest female relative of all soldiers of the Australian Imperial Force and the Naval and Military Expeditionary Force who have left Australia since 4th August, 1914, for Active Service abroad, or who have joined the above Forces but died in Camp or Military Hospital in Australia without having embarked.
- 2. The mother of a married soldier may receive a badge as well as the wife, provided that one badge only may be issued to the one female relative.
- 3. Bars will be attached to the badges to be issued to mothers who have more than one son on service. The badge indicates one son, and for every additional son serving a bar will be issued.
- 4. If an officer or soldier, be married or a widower, a badge will be issued to the nearest female relative in accordance with the following degrees of relationship:—
 - Ist. If an officer or soldier be married, the badge will be issued to his wife. The mother of a married officer or soldier may also receive a badge on his account in the event of no single son being on service; or
 - 2nd. If an officer or soldier be a widower, the badge will be issuable to his eldest daughter living; or
 - 3rd, If an officer or soldier be a widower without a daughter, his eldest sister may receive the badge.
- 5. If an officer or soldier other than a widower be unmarried, the degrees of pationship will be as follow:—

Mother.

Eldest sister.

Where there are twin sisters, he badge will be issued to the elder twin sister.

- 6. In the event of any officer or soldier not having any living female relative as described above, it will be necessary for him to nominate, in writing, his nearest female blood relation.
- 7. In the case of an officer or soldier having no female relative, and a foster mother having reared the lad, the foster mother is extitled to receive a badge.
